- Director claimed at no cost 3 tall shelving units from Cutlerville. Shelving will be installed in the fall. Rearrangement with the additional shelving will allow a handicapped access at the west entrance to be provided and a dedicated 'tween' book section.
- Auditors this week Thursday. Inquiries about the Risks of Fraud questionnaire completed by Library Board President.
- Staff meeting with director to discussion summer reading and next millage. Library Board complemented staff on a successful summer reading program.
