Vote motioned for technology upgrades for the library director to include a new laptop, computer screen and docking station not to exceed \$2,000.00, seconded by Gibson. All yes, motion carried. A request will be made to the Hopkins Library Board for financial assistance because of director's employment by both library boards.
